5.	<b>2015 taxable value lost because court appeals of ARB decisions reduced 2015 appraised value.</b> <b>A.</b> Original 2015 ARB values: <span style="float: right;"><u>\$0</u></span> <b>B.</b> 2015 values resulting from final court decisions: <span style="float: right;"><u>\$0</u></span> <b>C.</b> 2015 value loss. Subtract B from A. <span style="float: right;"><b>\$0</b></span>	
6.	<b>2015 taxable value, adjusted for court-ordered reductions.</b> Add Line 3 and Line 5C.	<b>\$69,839,012</b>
7.	<b>2015 taxable value of property in territory the school deannexed after Jan. 1, 2015.</b> Enter the 2015 value of property in deannexed territory.	<b>\$0.00</b>
8.	<b>2015 taxable value lost because property first qualified for an exemption in 2016.</b> Note that lowering the amount or percentage of an existing exemption does not create a new exemption or reduce taxable value. If the school district increased an original exemption, use the difference between the original exempted amount and the increased exempted amount. Do not include value lost due to freepport, goods-in-transit exemptions.  <b>A.</b> Absolute exemptions. Use 2015 market value: <span style="float: right;"><u>\$64,495</u></span> <b>B.</b> Partial exemptions. 2016 exemption amount or 2016 percentage exemption times 2015 value: <span style="float: right;"><u>\$335,704</u></span> <b>C.</b> Value loss. Use only properties that qualified in 2016 for the first time; do not use properties that qualified in 2015.</p> <p>A. 2015 market value: <span style="float: right;">\$584,140</span></p> <p>B. 2016 productivity or special appraised value: <span style="float: right;">\$24,540</span></p> <p>C. C. Value loss. Subtract B from A. <span style="float: right;">\$559,600</span></p>	
10.	Total adjustments for lost value. Add Lines 7, 8C and 9C. <span style="float: right;">\$959,799</span>	
11.	2015 adjusted taxable value. Subtract Line 10 from Line 6. <span style="float: right;">\$68,879,213</span>	
12.	Adjusted 2015 taxes. Multiply Line 4 by Line 11 and divide by \$100. <span style="float: right;">\$716,343.82</span>	
13.	Taxes refunded for years preceding tax year 2015. Enter the amount of taxes refunded by the district for tax years preceding tax year 2015. Types of refunds include court decisions, corrections and payment errors. Do not include refunds for tax year 2015. This line applies only to tax years preceding tax year 2015. <span style="float: right;">\$0.00</span>	
14.	Adjusted 2015 taxes with refunds. Add Lines 12 and 13. <span style="float: right;">\$716,343.82</span>	
15.	<p>Total 2016 taxable value on the 2016 certified appraisal roll today. This value includes only certified values and includes the total taxable value of homesteads with tax ceilings (will deduct in line 17). These homesteads include homeowners age 65 or older or disabled.</p> <p>A. Certified values only: <sup>3 Tex. Tax Code § 26.012(6)</sup> <span style="float: right;">\$93,757,465</span></p> <p>B. Pollution control exemption: Deduct the value of property exempted for the current tax year for the first time as pollution control property: <span style="float: right;">\$0</span></p> <p>C. Total value. Subtract B from A. <span style="float: right;">\$93,757,465</span></p>	
16.	<p>Total value of properties under protest or not included on certified appraisal roll.</p> <p>A. 2016 taxable value of properties under protest. The chief appraiser certifies a list of properties still under ARB protest. The list shows the appraisal district's value and the taxpayer's claimed value, if any or an estimate of the value if the taxpayer wins. For each of the properties under protest, use the lowest of these values. Enter the total value. <span style="float: right;">\$55,330</span></p> <p>B. 2016 value of properties not under protest or included on certified appraisal roll. The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about, but are not included at appraisal roll certification. These properties are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year. Debt includes contractual payments to other school districts that have incurred debt on behalf of this school district, if those debts meet the four conditions above. Include only amounts that will be paid from property tax revenue. Do not include appraisal district budget payments.</p> <p>B. If using unencumbered funds, subtract unencumbered fund amount used from total debt.</p> <p>C. Subtract state aid received for paying principal and interest on debt for facilities through the existing debt allotment program and/or instructional facilities allotment program.</p> <p>D.
